Who is Michael Daugherty? He is the man who fought the Deep State for a decade, and won.





Frustrated motorist takes on BLM protesters blocking intersection

The Texas motorist was forced to confront take matters into his own hands

A Texas motorist has gone viral after a video of him confronting a Black Lives Matter mob appeared online.

In the footage that was uploaded to Twitter, a police officer appears to stand back and permit the protesters to block traffic from flowing through the intersection, prompting outrage from drivers.

The incident took place last Sunday, the Dallas Observer [reported](#).

Protesters were blocking a busy intersection in Plano, Texas, causing traffic to back up for miles.

"Get the f*** out of my way!" the man screamed as he stormed over to the chanting mob.

The Texas motorist was furious that the mob was left to block the busy intersection

"Where's the godd*** cop?" he yelled in disbelief.

He then found a cop standing by the intersection, who was seemingly allowing the protesters to block traffic.

"Get these f***ing people out of the way!" the man screamed at the cop.

"They can't be standing in the middle of the road!"

The protesters then swarmed the man as he squared up to fight.

One of the demonstrators, attorney Lee Merritt, attempted to intervene to de-escalate the situation, the Observer [reported](#).

As tensions quickly rose, the officer escorted the angered motorist away from the protesters and back toward his car.

The video did not show the police officer clear protesters from the intersection.

According to the Dallas Observer, protesters were demonstrating after 26-year-old Marvin Scott III died while in police custody in March.

Is this how it's going to be? — Ed.

Seven of the eight police officers allegedly involved in Scott's death, [which was ruled a homicide](#), were fired, while the eighth officer has since resigned.

The man was stunned that a cop was seemingly allowing the mob to block the road

Hava Johnston, who was involved in the protest, said demonstrators were making their way to a nearby Chick-fil-A when they crossed through the intersection and blocked traffic.

Johnston told the Observer the enraged motorist should have been arrested for his actions, claiming a black man would have been.

"The question is: Why wasn't that guy treated the same way that a person of color would have been treated?" she said.

The Plano Police Department has not publicly addressed the incident.

The case alleges the runoff election for the GA U.S. Senate seats, which was certified in February of this year, was illegally executed on many levels and so does not accurately reflect the will of GA voters. The lawsuit calls for a new election based on paper ballots as provided in Georgia law.

“The case does not rely on the anecdotal evidence of ballot harvesting, dead citizens voting, or stuffed ballot boxes to seek to overturn the GA Senate election. This case is different because it involves a solid, objective examination of whether the voting machines used in the election meet the required GA statutory standards. The answer is — they do not. Since they do not, the election must be invalidated,” declared Daugherty.

“I involved myself because many people in the Georgia political establishment feel free to break election law and they’ve done it for a long time,” said Daugherty to

CDMedia. Daugherty added “Honestly, I do not understand how some of these people think they can disregard the law and act as they feel expedient for their own interests, vilifying anyone who disagrees.”

“You can’t ignore election law violations by anyone, much less the political establishment. While there needs to be a high bar, deadlines and finality, the politicians today feel they can violate every rule there is; to them the ends justify means. Frankly the widespread disregard for the law is disgusting.”

“The Trump cases had to have proof before engaging in discovery in order to challenge the results, but there was so little time. The system is simply rigged to permit fraud to flourish and succeed. But we have had the luxury of time. We’ve had time to lay the groundwork to go after everyone, and this will surely include the outrageous Stacey Abrams consent decree, the astonishing Dominion agreement, and potentially Dominion itself. “Voters” who were not registered to vote or did not vote in November suddenly voted in January. That was also illegal, and we are going to bring all this to light and hold the actors accountable.”

Daugherty quietly filed his case on a Sunday night in February. Biding his time, his team has held their fire until now. But then Perkins Coie, known as the Democrat storm lawyers of election mayhem, parachuted into the Daugherty case.

“With the recent ruling that takes the case out of Fulton, things will start moving fast. The impetus of this case is not political, nor for either side. It’s simply about free and fair elections. We cannot survive as a nation with voter fraud, systemic fraud and national distrust of election integrity. This destruction of American democracy has to be stopped.”

Daugherty is the perfect storm, an iron man of the force of will and in possession of a sharp legal mind.

With the tide turning in public opinion across the land regarding election fraud, this case is one to watch.

New Yorker: Liz Cheney was behind op-ed attacking President Trump

It looks likely that Rep. Liz Cheney is not going to hold on to her position as chair of the House Republican Conference, largely because of her in-your-face, unrepentant anti-Trump attitude that bleeds over to his supporters, who are a large majority of the Republican base. But if she was counting on the anti-Trump media to throw her a life preserver, they just threw her an anvil instead.

The New Yorker revealed that Cheney secretly orchestrated a January op-ed in the Washington Times in which 10 previous Defense Secretaries (including her dad, Dick Cheney) denounced Trump. The letter falsely accused him (based on pre-election Democrat conspiracy theories) of planning to politicize the military by involving it in disputes over the election.

Do Whatever You Want?

'Do whatever you want': Software to manipulate totals found on voting machines, lawyer says Trump: 'This will prove true in numerous other states'

A lawyer fighting an election-fraud case in Antrim County, Michigan, has revealed that the voting machines there contained a software program that could have been used to manipulate vote totals.

In fact, lawyer Matthew DePerno said in a podcast interview that with the MySQL program installed on the machines, and them all being linked, someone with access could "do whatever you want."

DePerno, just a day earlier confirmed in a court hearing that there were 1,061 "phantom votes" in the county during the 2020 presidential election, because while a recount of ballots tallied 15,962, the Michigan secretary of state's database showed only 14,901 votes were cast.

His latest concerns were raised during an interview with JD Rucker at the NOQ Report.

Rucker said the bombshell that DePerno delivered was that all of the voting machines were connected to each other through an intranet, that itself was not connected to the internet. However, he said a laptop computer with access to the intranet and access to the internet was left on during the Election Night counting.

He explained, "What we've seen in Antrim County is that all of the computers in the county are connected on a dedicated network, an intranet. So, remember back when I was coming up as a lawyer, we had email within the office that wasn't connected to the internet. It was self-contained, an intranet, right, a dedicated email network. They have the same thing in Antrim County even today, a dedicated

network where everyone can communicate, but they tell us it's not connected to the internet."

But DePerno explained maladjustments in the voting totals could have been done remotely.

Did Donald Trump actually win re-election in 2020?

99% (665 Votes)

1% (6 Votes)

"All you need anywhere along that point of any connection is someone to breach the network who has a connection to the internet and they can access everything. And we know in Antrim County on Election Night on November 3rd, that somebody left their computer on with an open VPN port."

Further, he explained that the MySQL program it not certified for the voting system.

"And you can use that system to manipulate the votes. You can use that system to go right into the Election Management System database and do whatever you want," he charged.

In the county a previous recount found Trump with 9,749 votes and Biden with 5,959. Across the state, Biden won by only about 150,000.

But Antrim was the county where officials first awarded the win to Biden, later saying that human errors were caught and confirming that Trump won.

And Michigan was one of six battleground states that drew charges of election fraud. Several states suspended counting on Election Night with Trump leading. Hours later, after massive ballot dumps that were nearly 100% for Biden, the Democrat took the lead when counting resumed.

DePerno explained that if fraud is confirmed, the problems begin.

"Fraud, as they say, fraud vitiates everything. It wipes it out. If there is fraud, what happened never happened in terms of the results. So, in Antrim

County, our first goal is to ensure that Antrim County is not certified or decertified. It should never have been certified in the first place and I'll tell you why," he said.

Rucker called for a full-blown investigation based on the statements from DePerno, who explained the installation of MySQL demonstrates intent to manipulate the database as there is literally no other reason to do this ahead of Election Day and confirmed a laptop was left connected to the system that had internet access.

"Anyone with internet access anywhere in the world, an understanding of MySQL, and a desire to manipulate the vote counts would have been able to do so," Rucker summarized.

Earlier election officials there identified "glitches" that switched 6,000 Trump votes to Biden initially.

And, the report said, a forensic audit found an error rate of 68.05%, while the Federal Election Commission allows a rate of no more than .0008% for all voting machines.

But then, the report said, "The ballot-adjudication logs and the security logs for the November 3 general election were removed. All log files for previous elections were still contained on the machines, but someone on the inside was able to erase the all-important log files for the 2020 election."

The pending lawsuit, filed by DePerno representing Antrim resident William Bailey, was the subject of a virtual hearing this week. Election officials are trying to get it thrown out.

Former President Trump endorsed the fight.

Local Man Fights School Board and WINS for Kids and Taxpayers!

Bob Vaeth has been fighting for a charter school for Volusia County kids for several years. But the VCSB kept turning him down. Scholars Line Up to Join Anti-'Woke' Online Education Platform

Hundreds of scholars, including some distinguished figures, have applied for positions at an online [education](#) startup that promises explicitly non-“woke” instruction in a number of academic disciplines.

Named “[American Scholars](#),” the project was started several months ago by Matthew Pohl, former University of Pennsylvania admissions officer. As soon as word got out, résumés started to stream in from academics offering their participation, its leaders said.

Pohl described the project as the fruit of his gradual disillusionment with his career in the academic world, where he drove admissions at several prestigious universities. He noticed that with regard to education, most students weren't getting their money's worth, attributing that to the “administrative bloat” of establishment colleges, as well as the spread of quasi-Marxist ideologies that have come to be collectively known as “wokeness.”

He intends the project as an antidote to both. The interactive format of part-lecture, part-documentary video with quizzes, and feedback sessions will aspire to demonstrate that quality learning can be furnished at a fraction of the cost of a modern-day college. Meanwhile, the content itself will be rooted in traditional American values, in sharp contrast to the ideologies currently dominating most universities that promote hostility toward such values.

“There is a massive and unrecognized demand for actual professors, business leaders, real thinkers whom regular people can associate with and learn from to better understand how they can live better lives through the Constitution and through conservative values,” Pohl told *The Epoch Times*, later adding that the guiding principles of the project could be more accurately described as “classical liberalism.”

“We actually expect a significant number of people who do not identify as conservative to join us—simply because they agree with our values,” he said in an email.

For the role of chief academic officer, who is responsible for the scholarly grade of the content, Pohl tapped Michael Rectenwald, a retired liberal studies professor at New York University.

Having given up his communist beliefs, Rectenwald left his job after he irked colleagues by criticizing the woke ideology. He went on to become an [authority on corporate socialism](#), a convergence of government and business interest in establishing a novel form of totalitarian, socialist rule. He's authored several books on the topic, [including](#) “Google Archipelago: The Digital Gulag and the Simulation of Freedom,” which warns against the rising power and ambitions of gigantic digital companies.

American Scholars will offer modules taught by bona fide academics on history, the Constitution, the natural sciences,

math, writing, business, economics and personal finance, ideological studies, literature, technology science, law, and religious studies, Rectenwald said.

He's already received applications from several hundred scholars, including some prominent names, from which he'll be soon picking the first 10 instructors.

“We even have chairs of departments interested in working for us,” he said.

Rectenwald shared with *The Epoch Times* a sample of the applicants' names under the condition that they won't be released for now, as none of them has yet been selected for any of the positions. In addition, Rectenwald has his own list of “top-notch talent” he'll ask to come onboard.

“It's going to be something where they're able to deliver content in the way they want to, without the pressures that are being exerted on them in the university system to accommodate various ideologies like [critical race theory](#) and socialism and postmodernism and so forth,” he said, adding that such ideologies also will be taught, but from a critical standpoint.

The first offerings, planned to start in the fall, will focus on history, the Constitution, economics, and personal finance, he said.

The material will be suited for homeschoolers, college prep, as well as adult learning.

The project doesn't seek to be accredited as an actual university, but rather to equip its alumni with the knowledge to “push back against some of the pernicious ideologies that are being purveyed in the system,” Rectenwald said.

“We've got to be frank. We're in the midst of a major culture war.”

The content range, as well as the format of the platform, was selected based on a series of focus group polls of a total of about 1,000 families, Pohl said. Personal finance, for example, stood out as both an acute interest of the poll respondents as well as a blind spot of the current university system, where students often sign up for massive debt with little to no calculation of return on investment that would allow them to make such decisions adeptly, according to Pohl.

Development of the online platform is run by an expert who for now requires anonymity, due to his involvement with Big Tech, Pohl said.

So far, the project is self-funded with some offers coming in from investors, he said. He plans a subscription model starting at \$19 a month and scaling up to about \$39 a month for premium access.

American Scholars fits into a growing selection of education platforms that approach their material from a more traditional standpoint. The conservative Hillsdale College offers free courses on a variety of politically relevant subjects, while PragerU [recently began](#) offering an online education portal for K–12 students.

New High School Principal ... If only ...

To the students and faculty of our high school:

I am your new principal, and honored to be so.
There is no greater calling than to teach young people.



I would like to apprise you of some important changes coming to our school. I am making these changes because I am convinced that most of the ideas that have dominated public education in America have worked against you, against your teachers and against our country.

First, this school will no longer honor race or ethnicity.

I could not care less if your racial makeup is black, brown, red, yellow or white. I could not care less if your origins are African, Latin American, Asian or European, or if your ancestors arrived here on the Mayflower or on slave ships. The only identity I care about, the only one this school will recognize, is your individual identity -- your character, your scholarship, your humanity. And the only national identity this school will care about is American.

This is an American public school, and American public schools were created to make better Americans. If you wish to affirm an ethnic, racial or religious identity through school, you will have to go elsewhere. We will end all ethnicity, race and non-American nationality-based celebrations. They undermine the motto of America, one of its three central values -- e pluribus Unum, "from many, one." And this school will be guided by America's values. This includes all after-school clubs. I will not authorize clubs that divide students based on any identities. This includes race, language, religion, sexual orientation or whatever else may become in vogue in a society divided by political correctness.

Your clubs will be based on interests and passions, not blood, ethnic, racial or other physically defined ties. Those clubs just cultivate narcissism -- an unhealthy preoccupation with the self -- while the purpose of education is to get you to think beyond yourself. So we will have clubs that transport you to the wonders and glories of art, music, astronomy, languages you do not already speak, carpentry and more. If the only extracurricular activities you can imagine being interested in are those based on ethnic, racial or sexual identity, that means that little outside of yourself really interests you.

Second, I am uninterested in whether English is your native language. My only interest in terms of language is that you leave this school speaking and writing English as fluently as possible. The English language has united America's citizens for over 200 years, and it will unite us at this school. It is one of the indispensable reasons this country of immigrants has always come to be one country. And if you leave this school without excellent English language skills, I would be remiss in my duty to ensure that you will be prepared to successfully compete in the American job market. We will learn other languages here -- it is deplorable that most Americans only speak English -- but if you want classes taught in your native language rather than in English, this is not your school.

Third, because I regard learning as a sacred endeavor, everything in this school will reflect learning's elevated status. This means, among other things, that you and your teachers will dress accordingly. Many people in our society dress more formally for Hollywood events than for church or school. These people have their priorities backward. Therefore, there will be a formal dress code at this school.

Fourth, no obscene language will be tolerated anywhere on this school's property -- whether in class, in the hallways or at athletic events. If you can't speak without using the f-word, you can't speak. By obscene language I mean the words banned by the Federal Communications Commission, plus epithets such as "Nigger," even when used by one black student to address another black, or "bitch," even when addressed by a girl to a girlfriend. It is my intent that by the time you leave this school, you will be among the few your age to instinctively distinguish between the elevated and the degraded, the holy and the obscene.

No more semesters will be devoted to condom wearing and teaching you to regard sexual relations as only or primarily a health issue. There will be no more attempts to convince you that you are a victim because you are not white, or not male, or not heterosexual or not Christian. We will have failed if any one of you graduates this school and does not consider him or herself inordinately fortunate -- to be alive and to be an American.


